A guide to support that might be able to help you

We know it is a difficult time for everyone with the rise in the cost of living. In this leaflet you can find useful websites, organisations and advice to help you with rising costs. There's support available both locally and nationally for a wide range of issues.

Help for Families

Kent County Council (KCC) is working with schools to make sure that families who are eligible for benefits-related free school meals will receive vouchers to feed their children during school holidays. You will get a £10 voucher per eligible child, which can be spent in supermarkets and local shops.

If your child gets free school meals because they are in year 2 or below, you will still need to apply for benefits-related free school meals to get vouchers during the October and Christmas break. Contact your child's school if you are unsure what arrangements are being put in place for your family.

Childcare

All parents of children aged three to four can access 15 hours of free childcare. It does not matter how much you earn or how many hours you work. Some parents of children under the age of 3 may also be entitled for free childcare. Currently, parents of 2 year olds can access 15 hours a week of free childcare if they are in receipt of income support benefits, such as Universal Credit, and earn less than £15,400 a year.

30 hours of free childcare will be expanded to eligible parents of children over the age of 9 months and will start from April 2024.

From April 2024 working parents of 2 year olds will be able to access 15 hours of free childcare.

From September 2024, 15 hours of free childcare will be extended to all children from the age of 9 months.

From September 2025, working parents of children under the age of 5 will be entitled to 30 hours of free childcare a week.

Families can receive up to £2,000 a year per child or £4,000 if their child is disabled to put towards the cost of childcare. Money can help towards the cost of holiday clubs, before and after school clubs, childminders and nurseries, and other approved childcare schemes.

You can get Tax Free Childcare at the same time as the 30 hours free childcare if you are eligible for both. Please visit <u>https://www.gov.uk/tax-free-childcare</u>

Kids eat for Free

Asda Café: Children can eat a meal for £1 every day of the week. No minimum spend required. Adults can also buy a half price meal from 3 pm daily. Offer runs until the end of 2023.

Beefeater and Brewers Fayre: Up to 2 children under 16 can eat a 'free' breakfast when an adult buys an unlimited cooked breakfast costing £9.99-£10.50. Valid daily during breakfast hours.

M&S Café: Children eat for free when an adult spends £5 in café on weekdays. Includes main, side, fruit, and drink.

Morrisons: During October half term - children eat free every day with 1 adult meal purchased over $\pounds 4.49$.

Bills: Between the 23 October – 3 November 2023 - 2 Children aged 10 and under eat free all day Monday to Friday if 1 adult orders a main dish.

Sainsburys: Children can eat for £1 when an adult purchases a main meal for £5.20 or more. Valid from 11.30 am.

Free School Meals

If your child is below 19 years old, in full time education, and you receive benefits you may be able to get free school meals for them. Speak to your child's school or apply online at www.cloudforedu.org.uk/ofsm/kent

If your child is in Reception, year 1, year 2 they are entitled to universal free school meals, all children in these year groups can get a free school meal at school each day.

If your child gets free school meals because they are in year 2 or below, you will still need. to apply for benefits – related free school meals to get vouchers during the October and Christmas holidays. Visit <u>www.cloudforedu.org.uk/ofsm/kent/</u>

Free School Meals eligible families will receive an additional energy voucher for each eligible child via their child's school outside of this scheme. Eligible free school meals families will be receiving a voucher per eligible child for the value of £100 direct from their child's school during the Autumn term. Specified Adult Childcare credits.

If you are a grandparent who provides childcare for your grandchildren, you may be eligible for Specified Adult Childcare credits, which can be claimed by family members who care for a child under 12, usually whilst their parent is working. Help with the Cost of Living

Help for Household

The Government's 'Help for Households' campaign has lots of helpful information to help you, from checking whether you are eligible for Universal Credit, how to claim Pension Credit if you are on a low income, to extra money available for carers. Cost of Living Payments

The Government has announced further Cost of Living payments will be made between spring 2023 and spring 2024. These payments are:

- Up to £900 for people on an eligible low-income benefit will go direct to bank accounts and spread across payments over the year.
- £301 paid between 25 April 2023 and 17 May 2023 for most people on DWP benefits.
- £301 paid between 2 and 9 May 2023 for most people on tax credits and on other low income benefits.
- £300 paid between 31 October and 19 November 2023 for most people on tax credits and on other low-income benefits.
- £299 paid during spring 2024 for most people on tax credits and on other low income benefits.
- £300 for pensioner households if you are entitled to a Winter Fuel Payment for winter 2023 to

2024, you will get an extra £150 or £300 paid with your normal payment from November 2023.

If individuals are eligible, they will be paid automatically, and there will be no need to apply.

Budgeting Loans

You may be eligible for a Budgeting Loan if you have been on certain benefits for 6 months. This can be used for household items, rent in advance, and travelling costs. Visit <u>https://www.gov.uk/budgeting-help-benefits/eligibility</u>

Help for the Armed Forces

The Royal British Legion (RBL) has launched its Everyday Needs Grants program, designed to assist those who need help in a quick and easy way with essentials such as kitchen appliances, clothes, and energy costs. Grants are available of up to £2,400 over 12 months. Applicable recipients include serving and ex-serving personnel, and the wider Armed Forces community, including families, dependents, and carers. HERO Service

Help with your Income

If you are on a low income, you may be entitled to Universal Credit, Tax Credits, and other benefits. There are many different forms of support available depending on your individual and household circumstances.

It is worth checking online at <u>www.gov.uk/benefits-calculators</u> to see if you are entitled to additional help. Make sure you have details of your household savings, income (including pension and benefit payments), outgoings (such as rent, mortgage and childcare payments) and your Council Tax bill to hand.

Housing Costs

Whether you are a tenant in the social sector or private sector or you have a mortgage, it is important that you talk to your landlord or lender at the earliest opportunity if you think you will have difficulty paying your rent and bills, as they may be able to help you. You could also be entitled to the following to help with your housing costs:

Sevenoaks District Housing and Community Hub

The hub provides a one stop shop for residents to discuss any issues and concerns they have with our staff partners in person. Areas of support include, but is not limited to:

- Cost of living
- Saving money on fuel bills
- Housing Advice
- Welfare Benefits
- Substance Misuse Support (Drugs/Alcohol)

No need to book, you can drop into our hub, which is held every month at our Argyle Road office. Our next hub days are being held on:

- Monday 13 November 2023 2 pm to 4.00 pm
- Wednesday 6 December 2023 10 am to 12.00 pm

Rough Sleeper Drop in Service

If you are single and homeless, Porchlight run a drop in housing and support service at the Swanley Link, London Road, Swanley BR8 7AE every Tuesday morning between 9.30 am to 12 pm. No booking is necessary.

For an appointment with our Rough Sleeper Officer at our Council office at Argyle Road, we offer a housing advice and support service on alternate Thursdays. Email our Housing team at housing@sevenoaks.gov.uk to book.

Discretionary Housing Payment

Discretionary Housing Payments (this applies to both social and private sector tenants) can provide extra money if your local council decides that you need extra help to meet your housing costs on top of what benefit support you already receive through the DWP.

To get a Discretionary Housing Payment, you will need to either already be receiving the old scheme Housing Benefit or the housing contribution element through Universal Credit. To apply for a Discretionary Housing Payment, please visit <u>www.sevenoaks.gov.uk</u> for further details.

Council Tax Reduction

Council Tax Reduction may be available if your household is on a low income. You could receive

Upcycling

Repair Cafés are free meeting places and they are all about repairing things. Take along your broken items - toasters, lamps, hair dryers, clothes, bikes, toys, crockery... anything broken is welcome.

Broadband Discounts

Not all of us regularly switch supplier, but it is worth comparing as you could save hundreds of pounds over the year. Anyone concerned about falling behind on payments should contact their Broadband supplier to see what support is available.

Social Tariffs

If you are in receipt of benefits, then special discounted home broadband packages are available. These packages, known as Social Tariffs, are offered by broadband providers and can be vital for families struggling with bills, keeping them connected even in tough times. Subject to eligibility, customers on social tariffs could in some cases save over a hundred pounds a year. Health Care Costs

Healthcare Travel Costs

if you are receiving Universal Credit or on a low income, you may be able to claim travel costs refund for hospital appointments. Visit <u>NHS - Healthcare Travel Costs Scheme</u> for more information.

Prescription Payment Certificate

The current prescription charge is £9.35 per item. You can save money on prescription costs, by buying an NHS prescription prepayment Certificate. There are 2 options to choose from:

- A 3 month prepayment certification costs £30.25. It will save you money if you need more than 3 prescribed items in 3 months
- A 12 month prepayment certification costs £108.10. It will save you money if you need more than 11 prescribed items in a year

Exemption from costs of Prescription Medication

You could get free prescription medication if you are receipt of benefits, on low income or those with certain medical conditions. Visit <u>NHS - Exemption from Prescription Medication</u>

Ask if your Prescription Medication can be brought over the counter. You can buy some prescription medications for minor health issues over the counter at a pharmacy or supermarket. Your local pharmacist can tell you if the medication is available or cheaper to buy over the counter.

NHS yearly HRT Certificate

If you pay for NHS prescribed HRT medicine 3 or more times in 12 months, an HRT Prescription Prepayment Certificate (PPC) could save you money. Each item on an NHS prescription usually costs £9.65. You can buy an HRT PPC for a one-off payment of £19.30. The HRT PPC covers an unlimited number of certain HRT medicines for 12 months. The HRT PPC does not cover all HRT medicines. Dental Care

You do not have to pay for NHS dental services if you are:

- under 18, or under 19 and in full-time education
- pregnant or have had a baby in the last 12 months
- being treated in an NHS hospital and your treatment is carried out by the hospital dentist (but you may have to pay for any dentures or bridges)
- receiving low-income benefits, or you are under 20 and a dependent of someone receiving low income benefits

You could get £69.70 a week if you care for someone for at least 35 hours a week and they get certain benefits. You do not have to be related to, or live with, the person you care for. <u>Check if you are eligible for the Carer's Allowance</u>

Support with Travel costs

Railcard

There are a number of railcard discounts available for families, young people, seniors, veterans, and disabled persons. Up to a third can be saved on rail fares by applying for a railcard. Visit <u>www.railcard.co.uk/</u> for more information.

JobCentre plus Travel Discount card

Provided to those unemployed claiming Jobseekers Allowance or Universal Credit for 3 to 9 months (18 to 24 year olds) or 3 to 12 months (over 25s) can apply through their Work Coach and local JobCentre Plus. Other benefit recipients may receive a Jobcentre Plus Travel Discount Card from 3 months of their claim and if they are actively engaged with a Jobcentre Plus adviser. Cardholders are entitled to a 50% discount on selected rail tickets. Contact your nearest Jobcentre for more information at https://find-your-nearest-jobcentre.dwp.gov.uk/

Kent Karrier Dial a Ride Service

This is a flexible dial a ride service that takes members from their door to anywhere in the Sevenoaks District. All services have a wheelchair accessible vehicle. To be eligible for the service you must be over 85 or live in a rural area more than 500 meters from a bus stop or train station, or you have a mobility impairment.

A small membership fee applies but you can make savings on your travel costs.
