#### 16 Apologies and Absences

Cllr Firmager sent his apologies which were accepted by the Chairman

#### 17 Declarations of interest or lobbying

There were no declarations of interest or lobbying regarding items on this agenda that have not been notified previously

#### 18 Minutes of Previous Meeting

The minutes of the meeting on 6<sup>th</sup> January 2025 which had previously been agreed by email were formally resolved by the Council and signed by the Chairman as a true record

# 19 Updates from KCC.

Cllr Chard did not attend the meeting. Cllr Weavers expressed her disappointment that Cllr Chard has stopped attending meetings. The Clerk was asked to contact Cllr Chard to see if he would be available to attend by zoom as he used to

## 20 Updates from SDC

Cllr Robinson commented on opportunities presented by Devolution. These Comments are included in agenda item 26.

Cllr Robinson mentioned an initiative from Bristol City Council where their black waste is only collected every 4 weeks. She stated both Sundridge and Brasted had discussed this initiative and expressed surprise it was not on the agenda. The Clerk commented that she had not heard of it and will contact her colleagues to find out the context of their discussions

Cllr Robinson mentioned the planning application at 26 Witches Lane and how it breaks the covenants in place on the land. The Council confirmed that as this was not a material planning consideration, covenants could not be taken into consideration when the Parish Council makes it's response to SDC

Cllr Alger updated on the Town redevelopment proposal and that KCC had withdrawn the library from the redevelopment and plans would have to be redrawn and unfortunately plans for a hotel in the centre of the town will have to be abandoned

Cllr Williams raised the crossing in Bessels Grenen. KCC report that the issue is that there are not many people who cross the road there and KCC have quoted £50k for a zebra crossing and £100k for a traffic light controlled crossing

# **Open Space Inspection**

Planters update – the Company who do Riverheads are now available to plant and tend to them (spring, summer & autumn planting and watering). It was resolved unanimously to employ them on that basis

# **Playground Inspection**

There are no reported issues with the playground

## 23 Otford Football Club

Otford Football Club requested to use Chipstead Rec for 2025/6 season for girls football on a Sunday morning and as a Reserve pitch on Saturday afternoons. 3 officials from Otford were present together with the Chairman of Chipstead FC. Chipstead FC have not played adult football on the main pitch in the 2024-5 season, but have decided they would like to return in 2025-6. The Council highlighted the concerns about parking and the congestion in the village caused especially by Saturday morning football where it is the Council's belief that there are simply too many children arriving in too many cars to be sustainable. Chipstead FC commented on the difficulty of getting volunteers to act as traffic marshals

The Chairman of Otford presented his proposals which included maintenance of the ground, cleaning up after games and employing a cleaner to come on Mondays to give a proper clean, fully marshalling all parking areas and introducing a "one way" system whereby anyone parking in the school or the Rec comes from Chevening end and anyone parking at Sailing Club Road comes from the centre of Chipstead. It was noted that the numbers of cars will be far less for Otford than on Saturday mornings

The two teams will get together to present a proposal as to how they will work together at the next meeting

# 24 VE Day Update

The Clerk confirmed the Big Red Pizza van will also be in attendance and she has contacted the Amblers to see if their licencee cricketer will provide a beer tent. The Chairman will also contact the Bricklayers Arms to confirm they do not want to provide a beer tent. There is a link on the PC Website to book a table

#### 26 Devolution

Cllr Robinson suggested the proposed devolution was an opportunity for Parish Councils to take control of land previously owned by SDC or KCC. The Council does not believe there is any SDC owned land within the Parish. There are a number of spaces owned by KCC – the biggest of which is Dryhill but the Clerk reminded the Council there are huge maintenance costs associated with taking on somewhere like Dryhill.

Cllr Robinson stated that in her research it shows that Unitary authorities need more people not fewer and she believes Parish Councils need to band together to be a strong unit. The Council agreed to review once the situation regarding KCC and SDC becomes more clear and more facts are known.

#### 27 Clerks salary.

The Clerks salary for 2024-5 is agreed at Government level and was resolved by the Council

# 28 Correspondence Received and General Issues

A Request had been received that the Parish Council tries to reinstate a later bus service through Chipstead village. This has been suggested many times but the bus companies do not believe it is a viable service. The Go-coach "Dial a ride" service is the model they are adopting to offer these services

Cllr Nielsen reported that Chipstead WI are raising money towards the defibrillator for the phone box in Stairfoot Lane

Cllr Weavers requested that Cllr Chard at least attend the PC meetings via zoom as he has not been to a meeting for many months

The Clerk is working with SDC Print services to get an editable version of "History of the Parish of Chevening" with a view t updating and reprinting it
