231 Election of Chairman

Cllr London was proposed by Cllr Woodruff, seconded by Cllr Nielsen and was unanimously re-elected as Chairman. Cllr London duly signed his acceptance of office.

232 Election of Vice Chairman

Cllr Eastwood was proposed by Cllr Weavers, seconded by Cllr de Turberville and unanimously elected as Vice-Chairman.

233 Apologies for Absence

Apologies were received from Cllr Moses and KCC and SDC Councillor Williams.

234 Declarations of interest or lobbying

There were no declarations of any interests or lobbying regarding items on the agenda.

235 Minutes of Previous Meeting

The minutes of the meeting held on 7th April 2026 were formally resolved by the Council and signed by the Chairman as a true record.

236 Updates from KCC and SDC Councillors

No Councillors were present.

237 Questions from the Public

There were no questions asked.

238 Annual Update by the Parish Council's Footpaths Warden

The footpath's warden gave a presentation to Councillors. He attended the annual meeting of the Kent Ramblers in Lenham and had also met with key members of both the KCC Public Rights of Way team

and Kent Ramblers. This has led to offers of assistance in replacing the Parish Footpath map on the green opposite the Bricklayers pub. Footpaths that he highlighted were Ash Platt Wood, a restricted byway that had been taken on by the Bessels Green Baptist Church, the Darent Valley Path had been

extended from Chipstead to Westerham, SR172 has been diverted to avoid the dangerous section of the B2211, SR181 has also been diverted to avoid the 70mph section of the A21/A25 Chipstead intersection. Councillors also asked about the sign at the beginning of Brickfields Lane. This is strictly correct as the footpath joins Chevening Road via a hole in the hedge in the middle of the Recreation Ground. On behalf of the Council the Chairman thanked the Footpath Warden for his hard work on behalf of all Parishioners.

239 Election of Working Parties, Representatives and Other Posts

The Working parties were discussed and resolved and are Appendix 1 to these minutes.

240 Standing Orders

A review of the Council's standing orders took place and was unanimously AGREED with one amendment to the timeline to agree the dates of the Council meetings for the forthcoming year which should take place at the Annual Meeting of the Council.

241 Financial Regulations

A review of the Council's financial regulations took place and was unanimously AGREED.

243 Chipstead Common Hut

The Secretary and Treasurer of the Sevenoaks Men's Shed introduced themselves and presented their proposal to Councillors. It was AGREED to continue discussions and Councillors felt that the project had great value to the Community. It was further AGREED that the draft Licence presented to Council be agreed in principle with some amendments to be approved at the next meeting, the clerk would obtain three quotes for cement cladding as providing both the best security and the best aesthetics. The Council would pay for the cladding but look for match funding. It was also AGREED that the name of the building would change from Chipstead Common hut to Chipstead Common Shed.

244 Open Spaces

Open Space Inspection

A bench had been vandalised on the Common, and the clerk had contacted MDH and asked them to remove it as it was beyond repair. It was AGREED to ask MDH to re-install the posts on the small green at Bessels Green.

a) Sailing Club

1st June 2026

Signed as a true record

An email had been received from Commodore Turtle informing the Council of the Club's intention of installing fencing to prevent unlawful ingress onto their property and to charge local residents a small fee to use the Club premises. Councillors AGREED to allow the Club to use the Council's noticeboards to advertise this. It was noted that a barrier had already been installed.

b) Sailing Club Road

Only one quote had been received so far. This item would be deferred to the next meeting.

245 CCTV

Following the recent flytipping in Sailing Club Road and instances of anti-social behaviour taking place late at night, it was AGREED to investigate the possibility of installing two self-contained 4k cameras along the road and one additional one on a residential property. These would be battery operated with a photocell. Quotes would be obtained and the police would be contacted for their support and advice.

246 Chevening Parkland Enhancement Scheme

The clerk had produced some notes on the recent liaison group meeting. The new Chief Executive of the Estate was present as well as Cluttons and Rural Arisings who were carrying out the works. Maps were presented to the group of a plan of works and rough timescales. All materials used on the parkland itself were made up of clean soil under the CLAiRE code of practice and the tyres and the hardcore was only used to build the roads onto the site. The footpath from the church to Turvins Farm would be widened a made disability compliant. The new Chief Executive wanted the estate to be more involved in the community and was interested in attending the Parish Council's 2027 Annual Assembly.

247 Pavilion

There was still some evidence of rodents in the loft; Plaxtol would be contacted to undertake further investigations. The clerk had contacted the handyman to enquire on progress of the remedial works.

a) Legionella Testing

The clerk presented a schedule of works that had been completed. One report had found higher amounts of bacteria in the cold taps than was advisable. This would be eradicated by flushing the taps through every week. A report was imminent that would confirm no legionella had been found. The report was noted.

b) Lighting

The quote from Phase Electrical for the works remedial works to bring the emergency lighting installation up to standard for the sum of £1290 plus VAT was AGREED. It was further AGREED to replace the disabled alarm which was not working for the sum of £220 plus VAT. The clerk was also requested to obtain a quote to install an AFDD.

248 Finance

a) Final Year End Accounts

Cllr Eastwood presented the final outturn to 31st March 2026 which was £867 over budget. Expenditure was higher on Pavilion maintenance and utilities. The general reserves stood at 68% of allowable limits and the CIL reserves were £19,732.

b) Insurance Policy

The Council's annual insurance was due for renewal in June. It was AGREED to accept the annual quote of £2318 from Zurich Insurance.

c) Income Received and Cheques Payable

The payments for May were AGREED and the Payments and Receipts for April were reviewed – Appendix 2.
